- a. **Board Update-** Insurance change for the Town and LVFD. The Township and the LVFD had their insurance quoted with Rural Mutual Insurance. We have decided to switch to Rural Mutual. The cost savings for the Town, apples to apples with Continental Western was \$3,440.00 and the cost savings for the LVFD, apples to apples with Continental Western was \$1,804.00. We have retained the Accidental Death and Disability Policy with Provident for \$1,855.00 as that is their specialty.
- b. **Board Discussion/Decision** CD is coming due soon. Shelley recommends we take the 7-month CD to pay for the second half of the truck, Greg agrees with Shelley. Travis made a motion to do the 7 month roll over, seconded by Dave. Motion carried 2-0.
